# Standard information management plan v2 Master asset list and mapping resource

# **Adoption Guidance**

### **Overview**

The master asset list and mapping resource have been developed with industry expertise to provide a consistent approach for asset identification, grading, geometry classification assignment and OpenBIM data exchange, using Uniclass and Industry Foundation Class (IFC).

It can be adopted by Scottish public sector clients and their delivery teams on projects using the Standard information management plan resource (\*) and Autodesk Revit software. The resource consists of:

- Master asset list: centrally hosted on Airtable: <u>https://airtable.com/shrIFHnD9ztZjweon</u>
- **Resource adoption guidance:** a step-by-step guide to support the master asset list, classification mapping integration and IFC export on your project model.
- **Master asset classification file:** for integrating the master asset list and classification data values into your project Revit model using the Autodesk Standardised Data Tool. (*Formerly the classification manager for Revit*)

# (\*) Before adopting the Master Asset Mapping Database and mapping file resource please refer to the SFT disclaimer in appendix A.

The master list is subject to change as new and existing assets are added and amended following live project feedback and periodical NBS Uniclass updates.

### **Resource adoption guidance**

To add classification values to your Revit model elements, there is a Standardised Data Tool from Autodesk BIM Interoperability Tools. Using this tool, you can add classification codes to selected models' elements, dependant on the classification system of choice.

Please note this guidance document only covers the Standardised Data Tool and you may still need to manually setup the COBie Extension to configure and export COBie depending on your project requirements. If required, this can be discussed with the BIM/ information manager on your project.

# Assigning Uniclass with the Standardised Data Tool

1. Under BIM Interoperability Tools tab select Assign Picklist under Standardised Data per figure 1

2. Using *Select One Now* load in the master asset classification file: SIMP2-SFT-XX-XX-SP-Z-0001\_S2\_Pxx\_Master\_Asset\_Mapping then click *Close*.

This file uses the following shared parameters:

Classification.Uniclass.Pr.Number, Classification.Uniclass.Pr.Description, Classification.Uniclass.Ss.Number, Classification.Uniclass.Ss.Description, Classification.NRM.Number, Classification.NRM.Description, IfcExportAs, COBie.Type.Category, IfcElementType[Type]

*Note 1:* The above parameters can be updated to suit your specific company standards or project requirements. Please consult with the BIM/ information manager on your project to ensure a consistence approach is maintained across the whole project team.

*Note 2:* Please note the following source notes regarding the Autodesk Revit parameter GUIDs:

- Classification.Uniclass.Pr.Number, Classification.Uniclass.Pr.Description, Classification.Uniclass.Ss.Number, Classification.Uniclass.Ss.Description, , IfcExportAs, COBie.Type.Category – GUIDs coming from BIM Interoperability Tools: COBie Extension file - COBie Extension Shared Parameters.txt
- IfcExportAs GUIDs coming from BIM Interoperability Tools: Standardised Data Tool file -SP\_StandardizedData.txt
- Classification.NRM.Number, Classification.NRM.Description GUIDs have been created for SFT through industry support.
- IfcElementType[Type] GUIDs coming from Autodesk GitHub Ifc Exporter Installation file *IFC* Shared Parameters-RevitIFCBuiltIn-Type\_ALL.txt

*Note 3:* Make sure *Set COBie Parameters* is ticked via *Options* per Figure 2 below – this will apply the classification code & description to COBie.Type.Category.

**3.** Select the *Assign Classification* on the Standardised Data Tool ribbon per figure 3, use the picklist icon per figure 4 to display the master asset list loaded in step 2.

**4.** Within your model view select the element type you want to assign a Uniclass Product (Pr) classification value to and look through/search the range to select an appropriate code from the master asset list.

*Note 4:* Uniclass Table Pr will add corresponding Uniclass Table Ss, IFC2x3, IFCElementType & NRM 3 at the same time.

*Note 5:* Uniclass Table Ss is for reference ONLY and should not be selected.

*Note 6:* IFC2x3 is for reference ONLY and should not be selected.

*Note 7:* IFCElementType is for reference ONLY and should not be selected.

*Note 8:* NRM 3 is for reference ONLY and should not be selected.

Once you complete this process and the product classification code has been added you can select the model element and go to Type Properties. You will now see that Classification Parameters have been applied to the element per the figure 5 example. Repeat the previous steps for all maintainable assets in the project.

*Note 9:* The above steps and notes ONLY apply to the master asset list range, and you may need to add further tables to the Standardized Data Tool to cover any additional assets as required by the client – if necessary, please discuss this with the BIM/ information manager on your project and inform the SFT BIM delivery group so they can update the master asset list.

## **Exporting Classifications to IFC**

Once the COBie parameter fields and Classifications are populated you are ready to export to IFC. Next you need to ensure Revit is pointed to the correct IFC mapping files. This should be discussed in advance with the project BIM/ information manager to ensure a consistent approach is maintained across the project and into the project information & asset information models.

5. Via the Revit File tab select > Export > IFC > modify setup> Property Sets >

**6.** Select Classification Setting per figure 6 and fill in the fields per figure 7 after agreement with the project BIM/ information manager.

*Note 10:* Dependant on which excel set up you are using will determine what shared parameters value you will add to the Classification field name. When using the SFT master asset classification file, you will need to add COBie.Type.Category to Classification field name box.

*Note 11*: Due to the Autodesk Revit Ifc exporter only being able to export one classification per element, any additional classification data will not be exported unless you use the ClassificationCode(n) series of parameters. If required, please consult the BIM/ project information manager for further advice on this.

*Note 12*: Unless the above note is actioned, the following shared parameters will not be exported to IFC - Classification.Uniclass.Pr.Number, Classification.Uniclass.Pr.Description, Classification.Uniclass.Ss.Number, Classification.Uniclass.Ss.Description, Classification.NRM.Number, Classification.NRM.Description.

*Note 13*: Please be aware the Classification.Uniclass.Pr.Number, Classification.Uniclass.Pr.Description are added to COBie.Type.Category as long Set COBie parameters (*per note 3*) is ticked at time of assigning the Pr code or *Classification Manager "Uniclass Pr" parameter* value is set to *First Priori*ty under COBie Extension Setup Project, Type, Category (*Figure 6*) and you run the COBie Extension Update with Type Category set to All.

*Note 14*: IfcElementType[Type] (*see IFCElementType (SFT) tab*) has been set to use the Uniclass Pr description as the Element Type (*figure 9*) where we have noted the Ifc Enumeration as USERDEFINED, this will be exported to Ifc automatically through the Autodesk Revit Ifc Exporter .
